

ORDINANCE NO. 15,858

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending 114- 2292, 114-2350, 114-2681, 114-2703, 114-2733, 114-3513 and 114-3682, and by adding and enacting new Section 114-2220.5, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending 114-2292, 114-2350, 114-2681, 114-2703, 114-2733, 114-3513 and 114-3682, and by adding and enacting new Section 114-2220.5, relating to traffic and vehicle regulations, as follows:

Sec. 114-2220.5. Gray's Parkway.

Gray's Parkway, at Southwest Twelfth Street, stop.

Sec. 114-2292. Murphy Street.

Murphy Street, at Southwest Sixth Street, stop.

Murphy Street, from the west line of Southwest Eleventh Street to the east line of Southwest Fourteenth Street, stop.

Sec. 114-2350. Tuttle Street.

Tuttle Street, at Southwest Sixth Street, stop.

Tuttle Street, from the west line of Southwest Eleventh Street to the east line of Southwest Fourteenth Street, stop.

Sec. 114-2681. Eighth Street--Pleasant Street to Park Street.

Eighth Street, on the west side, from Pleasant Street to a point 340 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Eighth Street, on the east side, from Pleasant Street to a point 85 feet north thereof, no parking any time.

Eighth Street, on the east side, from a point 85 feet north of Pleasant Street to a point 235 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Eighth Street, on the east side, from a point 320 feet north of Pleasant Street to Park Street, no parking any time.

Sec. 114-2703. Tenth Street--Mulberry Street to Walnut Street.

Tenth Street, on the east side, from Mulberry Street to a point 30 feet south thereof, no parking any time.

Tenth Street, on the east side, from a point 205 feet north of Mulberry Street to a point 40 feet north thereof, loading zone.

Tenth Street, on the east side, from a point 245 feet north of Mulberry Street to a point 50 feet north thereof, no parking any time.

Tenth Street, on the west side, from Walnut Street to a point 175 feet south thereof, commercial loading zone.

Sec. 114-2733. Southwest Twelfth Street-- Tuttle Street to Havens Avenue.

Southwest Twelfth Street, on the east side, from Tuttle Street to Gray's Parkway, no parking any time.

Southwest Twelfth Street, on the east side, from Davis Avenue to Elder Lane, no parking any time.

Southwest Twelfth Street, on the west side, from Davis Avenue to Watrous Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Southwest Twelfth Street, on the west side, from Watrous Avenue to a point 75 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Elder Lane to a point 75 feet north thereof, no parking any time.

Southwest Twelfth Street, on the west side, from McKinley Avenue to Hackley Avenue, no parking any time.

Southwest Twelfth Street, on the east side, from Porter Avenue to Army Post Road, no parking any time.

Southwest Twelfth Street, on the west side, from Highview Drive to a point 50 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from a point 50 feet north of Payton Avenue to a point 50 feet south of Payton Avenue, no parking any time.

Southwest Twelfth Street, on the west side, from Leland Avenue to a point 70 feet south thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Army Post Road to a point 50 feet north thereof, no parking any time.

Southwest Twelfth Street, on the west side, from Amos Avenue to Havens Avenue, no parking any time.

Sec. 114-3513. Murphy Street--Southwest Fifth Street to dead end west of Southwest Twelfth Street.

Murphy Street, on the north side, from Southwest Fifth Street to Southwest Ninth Street, no parking any time.

Murphy Street, on the south side, from Southwest Fifth Street to a point 75 feet west thereof, no parking any time.

Murphy Street, on the south side, from Southwest Seventh Street to a point 235 feet west of Southwest Ninth Street, no parking any time.

Murphy Street, on the north side, from Southwest Eleventh Street to and including the dead end west of Southwest Twelfth Street, no parking any time.

Sec. 114-3682. Tuttle Street--Southwest Fifth Street to Southwest Fourteenth Street.

Tuttle Street, on the south side, from Southwest Fifth Street to Southwest Ninth Street, no parking any time.

Tuttle Street, on the north side, from Southwest Sixth Street to a point 75 feet east thereof, no parking any time.

Tuttle Street, on the north side, from Southwest Ninth Street to a point 70 feet west thereof, no parking any time.

Tuttle Street, on the south side, from Southwest Ninth Street to a point 75 feet west thereof, no parking any time.

Tuttle Street, on both sides, from Southwest Eleventh Street to a point 50 feet east thereof, no parking any time.

Tuttle Street, on the south side, from Southwest Twelfth Street to a point 60 feet west thereof, no parking any time.

Tuttle Street, on the north side, from a point 300 feet west of Southwest Twelfth Street to Southwest Fourteenth Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
