**Time and Place for Filing Sealed Proposals.** Sealed bids for the work comprising each improvement as stated below must be filed at or before 11:00 a.m. on July 16, 2019, in the office of the City Clerk, 1st Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, 50309.

**Time and Place Sealed Proposals Will be Opened and Considered.** Sealed proposals will be opened and bids tabulated at 11:00 a.m., on July 16, 2019, in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, for consideration by the Des Moines Metropolitan Wastewater Reclamation Authority Board (WRA Board) at its meeting on August 20, 2019. The Des Moines Metropolitan Wastewater Reclamation Authority (Jurisdiction) reserves the right to reject any and all bids.

**Time for Commencement and Completion of Work.** Work on each improvement shall be commenced upon approval of the contract by the WRA Board, and completed as stated below.

**Bid Security.** Each bidder shall accompany its bid with bid security as defined in Section 26.8 of the Iowa Code and as specified by the Jurisdiction.

**Contract Documents.** Copies of the contract documents will be available after June 18, 2019, from the City Engineer's Office, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa 50309, at no cost.

**Preference for Iowa Products and Labor.** By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

**Sales Tax.** The bidder should not include sales tax in the bid. A sales tax exemption certificate will be available for all material purchased for incorporation in the project.

### **General Nature of Public Improvement.**

WRA WDM Outfall Sheetpile Repair, 04-2019-021

The improvement includes all labor, materials and equipment necessary for the installation of approximately 943 V.S.F. of steel sheeting and installation of approximately 151 vertical H-piles to support existing sheetpile installed along the Raccoon River adjacent to the WRA West Des Moines Outfall, Phase 13, Segment 7 sewer, including site restoration, miscellaneous associated work, and cleanup; all in accordance with the contract documents, including Plan File Nos. 611-223/228, located along the Raccoon River near Commerce Drive, West Des Moines, Iowa.

This project shall be fully completed not later than October 31, 2019.
